8.a. Approval of an Intergovernmental Agreement with the Town of Frederick

Dean also provided information about when this will be presented to Town of Frederick's Board Members and stated that the Frederick PROST Commission adopted a resolution of support of the IGA last week which will take place on May 6, 2026. The Town of Frederick is planning to Adopt & Approve the IGA on June 3rd, 2026. CVPRD and The Town of Frederick came to the term to have the agreement go to 2030.

Deputy Director Bryan Hostetler gave a presentation to the Board of Directors, detailing the Cyber Risk Assessment Audit that CVPRD and Colorado Special Districts Liability Pool completed and the findings of said assessment. Some of those findings include AI Policies and the do's and don'ts when it comes to AI and best practices as whole, as well as updating the suggested changes that come from the audit assessment. Bryan discussed what PII (Personal Identifiable Information) is and what we do as a district to keep that information secure. In the presentation Bryan also discussed what the next steps are following this audit such as updating our Privacy Policy, engaging with district counsel and publishing the updated policies, and should a data breach happen, have a process on how to respond to the breach.
